**THE FIRST OF LONG ISLAND CORPORATION ANNOUNCES FOURTH
QUARTER CASH DIVIDEND OF \$.17 PER SHARE**

This represents a 13.3% increase over the dividend declared in the same quarter last year. The dividend will be paid on January 14, 2019 to shareholders of record on January 3, 2019.
